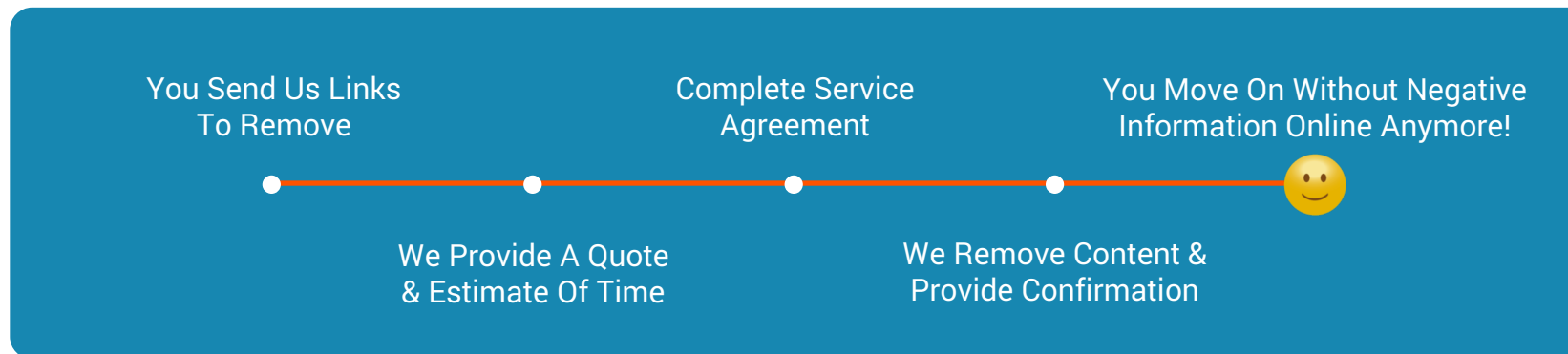
# How Does Content Removal Work?
